In addition to the new Campbell headquarters, the company has plans to open additional offices in San Francisco and the East Bay, and in Minneapolis, Minn. to accommodate growing teams across all departments. These new locations add to an expanding global presence for 8x8, which already has offices in New York City, London and Aylesbury in the U.K., Cluj-Napoca in Romania and Sydney, Australia.

The Creekside building is in an ideal location, adjacent to major freeways, minutes from the San Jose Mineta International Airport, and within walking distance to public transportation, hotels, restaurants and other amenities.
